GIFTS OF GRAIN

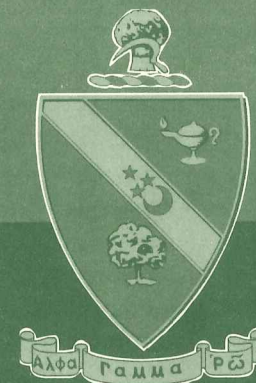
